




Premium spent is steadily increasing

In 2024, total premium payments in Denmark amounted to DKK 190 billion (EUR 26 billion) – an increase of 7% compared to 2023






People Risk and Property together account for two-thirds of total premium payments, with increases of 22% and 6% respectively
